If mandatory fees were in a structure such as technology fees by discipline, then the discipline was used that would reflect the typical student.

Further, SREB defines full-time for purposes of tuition calculation as **15 credit hours for undergraduate and 12 credit hours for graduate/professional**. If mandatory fees were in a structure such as technology fees by discipline, then the discipline was used that would reflect the typical student.
