Proposed FY16 Budget Overview

The proposed budget for FY16 follows this overview. The Board of Trustees approved a \$15 per hour tuition increase to start in the fall of 2015.

Several fees were consolidated and converted to per credit hour. Other fees added that were approved by the Board of Trustees during its April 2015 meeting include the following:

BH Science Lab Fee \$50 per course HVACR/EPA Testing Fee \$28 per credit hour T&I Student Uniform Fee \$40 per semester Drug Testing Fee \$10 per semester Cosmetology Fee \$17 per credit hour

Total revenues projected are \$46,765,420.15. Expenditures are by the same amount. Included in the budget is a contingency of \$415,000.

The proposed budget also includes personnel changes. Several positions were eliminated which is an estimated cost savings of \$879,392.01 include fringe benefits. Other positions were added under Academic Administration, Dean of Humanities, Institutional Effectiveness, Administrative Computing, PR & Marketing and Physical Plant. The cost of those positions is estimated at \$420,726.88.

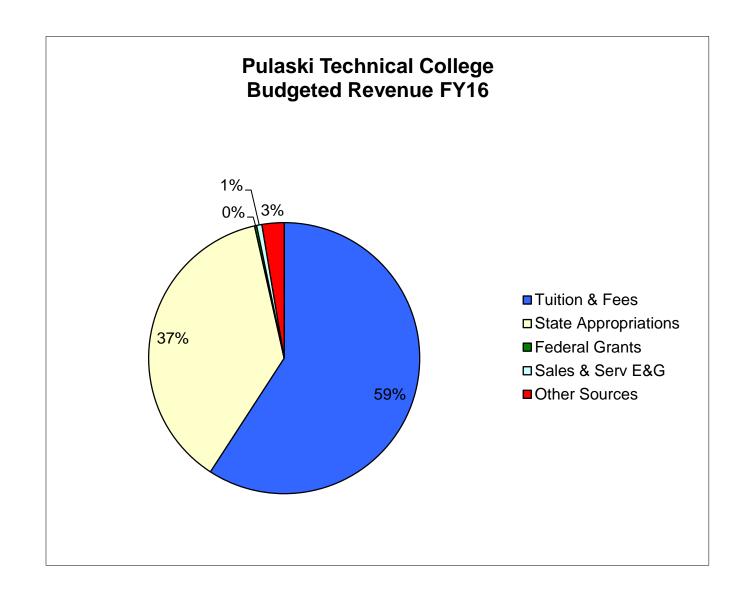
Workmen's compensation rate is 0 percent for FY16. Workmen's compensation was not budgeted, but workmen's compensation premium tax is included at the rate of .0435%.

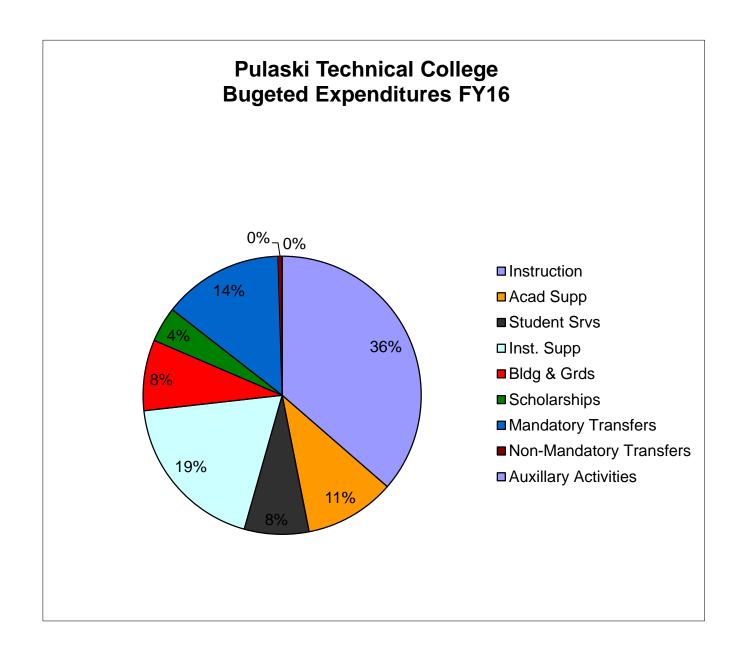
The construction of the Center for Humanities and Arts is expected to be completed by October 2015. Maintenance and operation of the Center for Humanities and Arts are included in this budget.

The debt service payments are estimated at \$6.4 million. We are limited to 25 percent of tuition and fees less unrestricted education & general scholarship expenditures that can be bonded for debt service payments by ADHE Coordinating Board Policy. Based on tuition and fees budgeted for FY16 our bonded indebtedness is limited to \$6,432,795.75.
